For Your Information: A person may be guilty of a misdemeanor under Revenue and Taxation Code section 6094.5 if the purchaser knows at the time of purchase that he or she will not resell the purchased item prior to any use (other than retention, demonstration, or display while holding if for resale) and he or she furnishes a resale certificate to avoid payment to the seller of any amount of tax. Additionally, a person misusing a resale certificate for personal gain or to evade the payment of tax is liable, for each purchase, for the tax that would have been due, plus a penalty of 10% of the tax or \$500, whichever is more.

The parties do hereby waive their right to trial by jury for any litigation arising between them for any claims relating to debt collection or merchandise, supplies or equipment purchased hereunder or hereafter.
